# MANS&C Board Supports BU before Biosafety Commission



MANS&C has stated its support for the Boston University Bio Lab in testimony submitted to the Boston Biosafety Committee, whose approval would be a near-final step in allowing the lab to begin research.

MANS&C Legislative Counsel John J. Spillane presented the board's position in written testimony submitted at a recent public hearing of the committee.

"The Boston University National Emerging Infectious Disease Laboratories (NEIDL) is a prime example of the types of considerable and beneficial contributions Massachusetts' nonprofit educational institutions make to our local economy," Spillane said.

The facility has undergone years of intense scrutiny on the local, state and national level, he pointed out, cautioning that:

"Undermining the intent of this development project, which has satisfactorily met all local permitting and development requirements, is a troubling precedent for the state's nonprofit community, a precedent that could potentially discourage private nonprofit institutions from investing in future development projects that would provide economic benefit to the commonwealth."

The lab's cutting-edge research will be used to diagnose, treat and cure infectious diseases for which no cures currently exist, Spillane said, adding that the lab also will benefit the commonwealth's innovation economy.

On behalf of the MANS&C board, he asked the committee to determine that the permit application is complete and to recommend its final approval by the Boston Public Health Commission. The Boston Biosafety Committee is an advisory group to the commission.

## **Legislative Report:**

#### **New Session Opens with Some Familiar Bills**

A new two-year legislative session opened in January on Beacon Hill, bringing with it both new and old challenges among its 5,875 recently filed bills.

The bills are currently being processed in the House and Senate clerk's offices, where they are recorded, numbered and then assigned to appropriate joint committees.

While this is going on, MANS&C Legislative Counsel John J. Spillane is using a comprehensive bill-tracking system to flag bills that are of potential concern to our MANS&C members. Several are bills that MANS&C helped turn back during the last session.

Among them are measures that would establish a special commission to study "the use and effectiveness of the Dover Amendment," which grants nonprofit educational institutions exemptions from certain zoning restrictions. This bill was re-filed by its sponsor, Sen. Michael Moore.

Another bill re-filed by Sen. Moore would establish detailed procedural requirements for nonprofit colleges and universities regarding dating violence, domestic violence, sexual assault and stalking.

Preliminary indications are that a number of bills this session will focus on child protection, including student privacy, bullying, concussions, sexual assault and other issues. Another focus will be school bus safety, including seatbelts on buses, health exams for bus drivers and cameras to photograph vehicles that fail to stop for school buses.

Other bills would give private school students access to the MCAS exams, and college students would gain the right to counsel for some school disciplinary hearings.


## Meet Sen. Michael D. Brady

After only two years in the Senate, Michael D. Brady was recently named Senate chairman of the Joint Committee on Revenue – one of the most influential committees on Beacon Hill.

Sen. Brady is a Democrat who lives in Brockton and is a life-long resident of his district, which includes Brockton, East Bridgewater (precincts 1 and 2), Halifax, Hanover, Hanson, Plympton, Whitman and Easton (precincts 1 and 2).

He was elected to the House in 2008 and then won a special to the Senate in 2015.
